Discussion ensued between Robin Tillman, Transit Director, Councilman Dr. Kora and Councilman Przybylinski regarding the route to PNW in Westville, and the funding of the matching grant.

Tommy Kulavik 1316 Ohio Street, addressed the council wishing everyone a Happy Black History month, stating the Transit Department needs to create a mobile app that would allow the public to purchase bus fares and show the bus schedule and routes.

Ms. Tillman advised Councilman Przybylinski that the grant they are receiving is 100% funded for the next three years to restore service to PNW and Laporte that was lost during Covid; and that they realize it is going to take time to build the ridership back to where it was.

Councilman Dr. Kora suggested this information regarding the route to PNW should be made available to the high school for possible future riders.

Councilwoman Moldenhauer thanked Ms. Tillman for her hard work and dedication; stating the residents in the "Tall Timbers" and "Green Acres" area need bus service in the 6th Ward.

WHEREAS, as a result of the multitude of marijuana dispensaries in New Buffalo, Michigan, Michigan City is now experiencing marijuana dispensary advertising billboards at several locations with City limits and City residents are receiving numerous pieces of advertising literature from said dispensaries in the U.S. Mail; and

WHEREAS, the Common Council reasonably believes that the residents of the City should not be exposed to said advertising as marijuana is still illegal in the boundaries of the State of Indiana;

Scott Meland, 200 Kenwood Place, addressed the council asking if there is current regulation on advertising within the city limits regarding alcohol and tobacco; if there is, marijuana could be added to those existing statues; if not he feels the state should handle this for prohibitions.

President Tillman asked if there were any other questions or comments from the public, there was no response.

President Tillman asked if the Council had any comments at this time.

Councilman Dabney stated this is not an enforceable resolution but a proposed resolution this council supports - House Bill 1026 that is being proposed at the state level.

Councilwoman Lee stated she also supports this proposed resolution as advertisements are being received, people are still being charged for possession of marijuana in Indiana; advising with the advertisements it makes this more appealing to our youth; if marijuana does become legal in Indiana, we could then revisit this issue.

Councilman Coulter stated he is in favor of the proposed resolution advising this would put marijuana in the same line with tobacco and alcohol at state level; if you can't have billboards with advertisements for one drug such as tobacco and alcohol then you shouldn't have them for others.

President Tillman stated she agrees that all advertising of any controlled substance; alcohol and tobacco should be prohibited and if the state of Indiana does make marijuana legal, we could revisit this matter at that time.

Tommy Kulavik, 1316 Ohio Street, addressed the council stating this a wonderful thing to dedicate this day to Namoi Anderson as this is also Private First Class Marine Danny Bruce Day who sacrificed his life serving our country in the Vietnam War.

Bonnie Shaff (Zoom) thanked the council for considering this proposed resolution to celebrate Naomi Anderson, inviting the council and public to attend the celebration for Naomi Anderson at the Michigan City Public Library on Saturday, March 1, 2025.

President Tillman asked if the Council had any comments at this time.

Councilman Przybylinski asked to be added as a co-sponsor.

The following council members also asking to be added as co-sponsors: Councilman Dr. Kora, Councilman Bietry, Councilman Dabney and Councilman Coulter advised they would like to be added as co-sponsors.

Councilwoman Moldenhauer made a motion to approve the proposed resolution, second by Councilman Dr. Kora, the motion carried, and the resolution was approved by the following vote: **AYES:** Council members Tillman, Bietry, Coulter, Dabney, Dr. Kora, Lee, Moldenhauer, Przybylinski (8) **NAYS:** Council member None (0).

ORDINANCES

President Tillman asked if there were any ordinances.

Clerk Neulieb advised there were no ordinances.

NEW BUSINESS

President Tillman advised the council has one (1) appointment to the Community Enrichment Corporation – Incumbent Stasi Benning term expires March 31, 2025.

UNFINISHED BUSINESS

President Tillman advised the council has two (2) appointments to the Revolving Loan Fund Committee Incumbents – Pia Parrott and Erica Miller (term expired October 18, 2024)

NOTE: one (1) member - senior level professional loan officer; one member is from business or retail who is a resident of Michigan City)

NOTE: Nominations for the Revolving Loan Committee were TABLED at the February 4, 2025 council meeting until the February 18, 2025 council meeting

President Tillman stated before we take the vote; she advised that at the Council's January 21, 2025 council meeting, the applicants that were nominated were Sheree Wilson and Scott Meland the vote was TABLED at the February 4, 2025 Council meeting until February 18th meeting to receive clarification regarding the language in the Revolving Loan Ordinance for these two (2) positions from Council Attorney Harris and Corporate Counsel Lapaich.

President Tillman stated their conclusion was that it does not specifically state in the revolving loan ordinance that the nominee must currently hold the title of a "Senior Level

Professional Loan Officer" stating that we will be moving forward on the vote of these two (2) positions this evening; asking the nominees to come forward and address the council regarding their proposed appointments.

Sheree Wilson,1030 Liberty Trial, addressed the council stating she has a background on construction and capital program management; advising she would aid new businesses in the process to help Michigan City grow.

Scott Meland, 200 Kenwood Place, addressed the council stating he was a former loan officer, realtor and private land lord and feels he is qualified for the position on the Commission.

Councilman Przybylinski questioned Mr. Meland qualifications; advising what is stated in the revolving loan ordinance is that the qualification to serve on this committee is be a "Senior Level Professional Loan "Officer".

President Tillman stated that legal advice has been received from Council Attorney Harris and Corporate Counsel LaPaich according to State Statue and description of the position of the "Senior Professional Loan Officer, and the council could at a later date make amendments to the ordinance regarding the qualifications to the appointments.

President Tillman congratulated the new appointments to the Revolving Loan Fund Committee.

Ernie Holland, 302 Gladys Street, addressed the council stating that there needs to be more factory and infrastructure jobs within the city along with affordable housing.

Scott Meland, 200 Kenwood Place, thanked the council for their support and vote to serve on the Revolving Loan Fund Committee; thanked Councilman Dabney for his clarification on the difference between a resolution and ordinance; advised the public on the housing market.

Tommy Kulavik, 1316 Ohio Street, addressed the council congratulating the Marquette High School girls' basketball team as they won their championship game; stating that Michigan City High School will be hosting the ISHA sectionals, regionals and semi-state this year for boys' basketball.

Brian Gross, 830 W. 6th Street, addressed the council on affordable housing.

President Tillman asked if there were any other questions or comments from the public, there was no response.

COMMENTS FROM THE COUNCIL

President Tillman asked if there were any comments from the Council at this time.

Councilwoman Moldenhauer invited the public to join the celebration activities for Naomi Anderson Birthday at the Michigan City Public Library on Saturday, March 1, 2025, at 2:00 p.m.

Councilman Przybylinski congratulated the two (2) appointments to the Revolving Loan Fund committee; advising why he abstained the second appointment; reading the following for the record; Ordinance No.4113 Sec. 3 "Said contract shall provide for the

creation of a loan committee by the Corporation that includes two senior-level professional loan officers, one appointed by the Mayor and one appointed by the Council"; and read the correspondence he received in its entirety from Council Attorney Harris and Corporate Counsel Amber Lapaich regarding the definition of the "Senior Professional Loan Officer."

Discussion ensued between President Tillman and Councilman Przybylinski regarding the time limit for council comments.

Councilman Coulter invited the public to attend the following events, the YMCA annual dinner on February 27, 2025 and also on March 9, 2025 sponsored by the "Trail Creek Water Shed Partnership" is working with the "Great Lakes Fishery Commission to host the showing of their recent movie "Fish Thieves"; and reach out to him for more information.

President Tillman stated Mayor Angie scheduled a workshop on Friday, March 14, 2025 at 5:00 p.m.in the EOC Room to discuss "Wheel Tax" legislation; that Senator Jim Pressel will be present to answer any questions.

President Tillman announced Mayor Angie's "Town Hall" meeting schedule and locations for the up-coming year.

ADJOURNMENT

A motion by Councilman Dr. Kora, second by President Tillman and there being no further business to transact, President Tillman declared the meeting **ADJOURNED** (approximately 8:20 p.m.)
