Michigan City Fire Merit Commission Meeting Minutes: February 3rd, 2025

The meeting was called to order at 5:00pm. All in attendance were asked to stand for the Pledge of Allegiance. Those in attendance were Vice President Adrian, Secretary Biege, and Commissioner Espar. Also in attendance was Fire Chief Barrett Taylor, Union President Chris Zibutis, and Commission Attorney Cory Shoffner. President Neulieb and Commissioner Deutscher were absent.

<u>Approval of Minutes-</u> A motion to approve the minutes from the January meeting was made by Commissioner Espar and was seconded by Secretary Biege. **Motion carried 3-0.**

Report from Commission Attorney- A question from the January meeting regarding the ordinance was brought up in conversation, Ms. Shoffner noted that if an individual refuses their promotion at the time they are still able to accept it when the next opportunity comes around without having to be moved to the bottom of the promotional list (Sec. 54-175). She also stated that if an individual refuses to accept, they have three days to produce a letter of refusal.
