### REPORT FROM HARBORMASTER

Harbormaster Tim Frame reported on the following:

- The Corps of Engineers has finished their dredging project and removed about 50,000 sq cu. Yd. of sand from the outer harbor. Another barge then pulled in to continue the NIPSCO piling project. Their crew is using 60 ft. piling and experienced trouble when the piling encountered a stone and rock layer. A heavier pile hammer was brought in to complete the project that is still expected to be completed by the end of June. The Corps of Engineers also pulled a stone barge in to continue adding stone to the outer breakwater. That project is expected to be finished within two weeks.
- Crews remain busy launching boats and lowering docks.
- Project to reinforce the north end of the Lighthouse pier is scheduled for 2026.

- Attorney Zaknoen shared discussions he had with the attorney for the Yacht Club recently and reported on the possible actions needed by the Board to continue finalizing an agreement for the lease of the deck around the Yacht Club.
- Motion by Bruce Manner, 2<sup>nd</sup> by Sam Ferguson to propose that the Board reject the Michigan City Yacht Club's counter proposals to the proposed lease as set forth in a letter dated April 17, 2025, from the Yacht Club's attorney to the Board's attorney. The Board will then cause a new Exhibit A defineating the Premises to be created, which will exclude from the Premises the pavilion, the area to the east and west of the pavilion, and the portion three feet north of the north side of the pavilion to be drafted. The Board agrees to extend the date by which the parties must conclude negotiations for a new lease until May 12, 2025. Motion passed unanimously.
