# REPORT FROM HARBORMASTER

Harbormaster Tim Frame reported on the following:

- MCPA Crews remain busy launching boats, adjusting finger piers and replacing dock boxes as needed.
- The Corps of Engineers added a second stone barge and finished adding stone to approximately 1/3
  of outer breakwater. Crews will return next summer to reinforce the north end of the the east pier by
  the Lighthouse.
- The NIPSCO sheet wall project continues and are on schedule to be finished by the end of June.
- One of the gas pumps is awaiting a replacement circuit and should be back in service soon.
