REPORT FROM HARBORMASTER

Harbormaster Tim Frame reported on the following:

- The Public Notice for the dredging project was sent to all adjacent owners of the marina
- The basin of the Washington Park Marina was treated for weeds. Crew will return in a few weeks to treat for another species of weeds.
- Marina staff continues to adjust finger piers, swapping dock boxes and minor repairs.

REPORT FROM ASSISTANT HARBORMASTER OF ADMINISTRATION

Mary Ann Pawlicke reported the following:

- The office staff is experiencing a high volume of in-person traffic and assisting boat owners and day-to-day requests.
- Mary Ann advised that \$614,000.00 needs to be transferred from the Operating Account to the Capital Improvement Account.
 - Motion by Sam Ferguson, seconded by Chris Cipares to approve the transfer of monies as directed by the State Board of Accounts. Motion passed unanimously.

Budget and Financial Oversight Committee

appropriate length slips this summer. The marina is monitored on an ongoing basis for any other
adjustments that need to be made based upon slip availability

- Chris Cipares revisited the information he presented at the last meeting about the Reigns of Life organization seeking a donation from the MCPA.

- Chris also reported that a lawsuit has been brought against a tenant of the marina, Harbor Country
 Adventures, by a small number of owners from the adjacent condominium project by the Franklin
 Street Bridge. He read a letter written by the owners of B&E Marina in support of the efforts
 undertaken by Harbor Country Adventures to benefit the marina area.

REPORT FROM THE ATTORNEY

- Attorney Zaknoen report that the Board has not approved the Licensing Fee for the Great Lakes Grand Prix Boat Races held in early August. He recommends imposing a \$1,000.00 licensing fee effective in 2026.
 - Motion by Sam Ferguson, seconded by Kim Sliwa to approve imposing a \$1,000.00 licensing fee for the Great Lakes Grand Prix Board Races effective in 2026 and waiving the fee for the 2025 race. Motion passed unanimously.
