Motion made by Commissioner Rodney McCormick to buy uniforms for Middle School Wrestling Team not to exceed \$1,000. And he will add \$100.00. Motion seconded by Commissioner Nick Pollock. Discussion. Motion put to vote- Vote was unanimous. Commissioner Rodney McCormick will send email request from the Wrestling Team Coach.

Education Committee - Commissioner Pastor Dwayne Hurt

Commissioner Rodney McCormick House Bill 1136 is a bill we should look into. This bill will affect Gary Westside School District, Tri Township and others and will dissolve the Gary Westside School District. Health: Commissioner Pastor Robert Johnson

Commissioner Robert Johnson has been hired as the Program Director for Minority Health Partners of LaPorte County. Minority Health is revamping and will have more health programs in 2025 for Michigan City, LaPorte City and LaPorte County.

Employment – Commissioner Willie Milsap

- Passed out folders with WorkOne Job Postings from November-Present for Michigan City and surrounding areas, Porter, Chesterton, Valparaiso, etc.

- Nick Pollock Carpenter's Union have a huge Solar panel project in Winamac (2) Microsoft data center in LaPorte (3) Amazon data base currently in New Carlisle.
- All trades need new members.
- Commissioner Johnson they getting ready to tear down KFC and Red Lobster buildings. Possible employment opportunities. Also Big Lots is closing. Michigan Blvd. added ACE Hardware Store in Eastgate Plaza.
- -Commissioner Rodney McCormick —Past Mayors and City Council did not hire City residents or make sure City residents were on these construction projects. We have been left out for awhile. We need to stand up for something. We need to work with Michigan City Human Rights Dept. and Code Enforcement Officer. In our Annual Report we need to stress to the City Council to enforce the Hiring Ordinance.
- -Commissioner Johnson You see projects and no Blacks on these projects.
- Commissioner Pollock said he spoke to Mayor and there is a new Code Enforcement Officer and Michigan City to enforce ALL CODES. Local Hiring Ordinance needs to be strengthened.
- -Commissioner Moore stated Mayor announced at City Council meetings last night she is scheduling 8 Town Hall meetings asking their Community to voice their opinion and she is revamping the Planning Department.
- -Commissioner Robert Johnson –this is very important. No Blacks on the projects going on in Michigan City needs to change. We need a percentage of Blacks.
 - Commissioner Rodney McCormick -|We need to do our part. The same people come out to the Town Hall meetings and walk away discouraged because nothing changes.

Commissioner Pollock – There will be a short employment committee meeting after this meeting.

<u>Criminal Justice</u> —Commissioner Taylor Tillman

Commissioner Rodney McCormick I want to thank LaPorte County Council again for the donation of \$4,000 to this Commission. I'm not coming back, but I will work on the subcommittee.

Council Liaison, Joseph Nelson stated that he didn't agree with putting someone from the County Council on this Commission.

This brought about a ten minute discussion. The outcome of this discussion is for someone else is appointed to this Commission from Michigan City Council that will support the Commission desires and votes. The majority of this Commission voted to include a resident from LaPorte City or County to be appointed in one of the vacant positions that already exists.
