## **MINUTES**

## REPORT FROM HARBORMASTER

Harbormaster Tim Frame reported on the following:

- Crew is in the process of turning off all the water and shutting down the bathrooms.
- Boats continue to be hauled out of the marina.
- Winterization activity and Christmas light installation began.

#### COMMITTEE REPORTS

### **Budget and Financial Oversight Committee**

Sam Feguson reviewed the Claims Docket prepared for October 20, 2025.

- Motion by Sam Ferguson, seconded by Dan Messina to pay all bills as presented. Motion approved unanimously.
- Sam advised the Board that he continues to work on the 2026 Budget with Ms. Pawlicke and progress has been delayed due to the computer issues with the city computer systems.
- Sam Ferguson reported that further discussion took place among Sam Ferguson, Chris Cipares, and Socrates Gray with staff regarding methods to recover costs associated with credit card processing fees for marina rental fees, services, and fuel purchases.
- Motion by Sam Ferguson, seconded by Bruce Manner to approve increasing dock fuel prices by \$.10 cents per gallon for both gas and diesel fuel. Motion approved unanimously.

Motion by Sam Ferguson, seconded by Dan Messina to implement a surcharge matching the
processing cost of credit card transactions for Slip Rentals and Services at the Port Authority
beginning January 1, 2026, if possible to offset fees charged by credit card companies. Motion
approved unanimously

#### Claims and Insurance Committee

# Port Operations & Personnel & Marina Policy

- Socrates Gray reported on his discussion with Chief Swistek concerning the Long Beach Police Department's request to use a slip for the new police boat. Chief Swistek advised that B&E Marina will take care of the vessel's maintenance and that the police will store the boat in their Long Beach garage when not in use. As no storage space at the marina will be needed. Socrates requested that a list of individuals authorized to use the police boat be provided to ensure proper oversight of access at the marina
  - Motion by Sam Ferguson, seconded by Dan Messina to provide the Long Beach Police with a 30-foot slip free of charge for the 2026 Boating season. Motion approved unanimously.

## Boater Communications and Special Events Committee

- Dan Messina reported that he has received compliments on the appearance of the new "Do Not Feed the Birds" sign installed at the marina.
- He also relayed a question about winter access to the boat launch ramp, and the Port Authority confirmed it is not blocked during the winter season.

Confirmed that the park board meeting did not include any topics relating to the Port Authority.
