2026 CDBG Annual Action Plan

Notice is hereby given that the City of Michigan City, Indiana will hold a Public Hearing on June 17, 2026, at 5:00 PM to receive input for the City of Michigan City's proposed 2026 Annual Action Plan. The Housing and Development Consolidated Plan's draft 2026 Annual Action Plan will be available for a 30-day public comment period beginning on June 8, 2026. Please contact the Community Development Block Grant (CDBG) Office at 219-873-1419 Ext. 2023 for more information. The purpose of this Public Hearing is to provide information concerning the amount of funds available for proposed Community Development and Housing activities; and the range of eligible activities that will be undertaken under the PY2026 Annual Action Plan. Individuals with disabilities who need auxiliary aids or special modifications including language translation to participate should contact the Community Development Office at least 72 hours in advance of the public hearing to schedule accommodations.

The PY2026 Annual Action Plan proposes how HUD funds will be used to meet the national objectives of decent affordable housing, a suitable living environment and expanded economic opportunities for low-income households and neighborhoods. The plan covers all activities to be funded through approximately \$652,522.00 in new CDBG funds which is a U.S. Department of Housing and Urban Development (HUD) funded program. The draft PY2026 Annual Action Plan also outlines programs and other housing and community development activities to be performed throughout the community.

Copies of the draft Annual Action Plan will be available beginning Monday, June 8, 2026, at the Michigan City Department of Planning and Inspection, 100 E. Michigan Blvd, Michigan City, IN 46360. Copies of the plan will also be available at the Michigan City Public Library, 100 E. 4th Street, Michigan City, Indiana and the City of Michigan City's website Community Development Department <https://michigancityin.gov/city-departments/community-development/>.

Notice is hereby given that the City of Michigan City, Indiana intends to apply for approximately \$652,522.00 in Federal Community Development Block Grant (CDBG) funds for Program Year 2026 to the U.S. Department of Housing and Urban Development (HUD) on or before August 12, 2026. The city plans on a total of \$652,522.00 to implement housing and community development activities within the city limits of Michigan City, Indiana. Pursuant to 24 CFR Part 91, the City of Michigan City is required to prepare and submit an Annual Action Plan for the use of CDBG funds. The Annual Action Plan represents the goals and objectives for the use of CDBG funds as outlined in the Five-Year Consolidated Plan.
